Please read carefully and complete the application on the back.

Summer I May 27 - June 27

- The first summer session will be part of the **2007-2008** award year and your eligibility will be limited to unused Pell Grant and/or loan funds.
- Limited amounts of Federal Work Study **may** be available.

Summer II July 1 – Aug 1

- The second summer session will be part of the **2008-2009** award year. Any Pell and/or loan amounts used will **reduce** your academic year eligibility (Fall 2008 and Spring 2009).

Summer III May 27 – Aug 1

- The third summer session will be part of the **2007-2008** award year and your eligibility will be limited to unused Pell Grant and/or loan funds.
- Limited amounts of Federal Work Study **may** be available.
- Financial aid **will not** be paid for Summer I **and** III or Summer II **and** III. Summer III is separate from I and II.

Basic Information and Requirements

- Admitted to Blue Ridge CTC in a degree-seeking program
- Making Satisfactory Academic Progress for financial aid at the end of Spring 2008
- Have completed a Free Application for Federal Student Aid (FAFSA) for the appropriate aid year(s)
- Have completed and submitted other materials as requested. Example: tax forms and verification form if selected for verification
- Enroll at least half-time (three hours for Summer I and II; six hours for Summer III) each session to be eligible for Direct Loans.
- **BE PREPARED TO PAY YOUR BILL IN FULL!** Application for summer aid **does not guarantee your aid and/or aid may not be processed prior to bills being due.**
