Perhaps no other issue on a college campus is more important than its accreditation. With proper accreditation, colleges are eligible to award federal financial aid and students can transfer credits between institutions more easily. Without it, federal financial aid would disappear. That would be a disastrous occurrence on almost any campus with which I am familiar.

The process of achieving and maintaining our institutional accreditation centers around the production of an Assurance Argument. That argument is our demonstration of why we should have our accreditation reaffirmed. It is a very important work, and it is in the process of being written now. The Assurance Argument starts with a clear Vision and Mission for Blue Ridge. Our governing board recently approved our revised Vision and Mission which I think you will find to be much more inclusive and streamlined than prior versions.

The steering committee for the Assurance Argument is in full swing writing, revising, and editing our document for the March 2020 visit. We anticipate that our final draft will be completed sometime before Christmas break and be ready to submit the Higher Learning Commission in anticipation of our visit. It is a prodigious task and we need to be grateful for all the work that is being done for the benefit of our students and us. It is interesting to note that on the Commission's website, Blue Ridge's 2014-2015 Assurance Argument is still listed as a model for others to follow.

We all trust that the 2019-2020 will be as good if not better. We have a great story to tell, and the Assurance Argument and this newsletter are fantastic ways to tell it.

#### WHY IS ACCREDITATION IMPORTANT TO BRCTC?

Only accredited institutions are eligible to receive federal funds for higher education, including student financial aid. Accreditation also ensures students the ability to transfer credits between accredited schools.

**Quality Education:** Accreditation assures academic program quality through accountability to external standards

**Financial Aid:** Accreditation enables us to maintain our eligibility to receive federal funds for student financial aid

**Credit Transfer:** Accreditation is an important factor when a college or university is deciding whether to accept transfer credit from a student's previous school. Most colleges and universities will not accept transferred course credits from an institution that has not earned appropriate accreditation status from an accreditation organization.

**Success in the Workplace:** Most employers prefer to hire job applicants who have gained their education from a college or university with the appropriate accreditation status. It is also common for states to require that a college, university, or program be accredited when allowing students to acquire state professional licensure.





As BRCTC prepares for the HLC visit, one might compare it to preparing to climb a mountain. This newsletter will help the BRCTC community be aware each step of our journey. An important step in climbing a mountain is to set your goals!

#### ARE YOU FAMILIAR WITH HLC TERMINOLOGY?

#### **Assurance Argument**

A narrative in which the institution explains how it meets HLC's Criteria for Accreditation, which is supported by linked documents in the Evidence File.

#### **Assurance Filing**

Created and submitted by the institution, the filing includes the Assurance Argument with embedded links to documents in the Evidence File.

#### **Assurance Review**

The peer review evaluation of the Assurance Filing.

#### **Assurance System**

An online system used by institutions to provide an Assurance Argument or Systems Portfolio and evidentiary materials and used by peer reviewers to complete the Assurance Review or Comprehensive Quality Review.

#### **Accreditation Liaison Officer (ALO)**

An individual identified by the chief executive officer of the institution to be second in the line of communication (behind the CEO) with HLC regarding policies, practices and other accreditation matters.

#### **Accredited Status**

Status that indicates an institution meets HLC's Criteria for Accreditation.

#### **Dual Credit Courses**

Courses taught to high school students for which the students receive both high school credit and college credit.

#### **Maintain Accreditation**

Actively participate, as an institution, in HLC's accreditation processes to ensure the institution meets the Criteria for Accreditation.

#### **Notice**

A sanction signifying an institution is pursuing a course of action that could result in its being unable to meet one or more of the Criteria for Accreditation.

#### **Student Opinion Survey**

An online survey conducted by HLC as part of comprehensive evaluations. The opinions and data gathered assist peer reviewers in developing questions for their meetings during the on-site visit

## ♣ 16 COMMON ASSESSMENT CRITERIA MISTAKES

While BRCTC was not cited for these citations, understanding the common ones will help us to aware of possible pitfalls! If you think you may be weak in these areas, please reach out to your supervisor or Laura Busey.

- 1. Most cited reason: Absence of systematic process to inform or improve student
- 2. Lack of assessment of co-curricular activities
- 3. Having a new plan in place with no data
- 4. No assessment of program learning outcomes
- 5. Incomplete submission of program assessment reports
- 6. No assessment of institutional data on general education outcomes
- 7. Lack of direct measures for assessment reports
- 8. No assessment plan
- 9. No process in place to collect and store data; no centralized data collection with accessibility
- 10. Lack of infrastructure or oversight of assessment
- 11. General Education assessment non existent
- 12. Not all programs have learning outcomes, making sure they are measurable
- 13. Faculty could not articulate how program and general outcomes are linked
- 14. Assurance argument is consistent with practice
- 15. Outcomes for courses or program are not publicly available.

#### DID YOU KNOW ...? FUN MOUNTAIN FACT!

The highest mountain and volcano in the Solar System is on the planet Mars. It is called **Olympus Mons** and is 16 miles (24 kilometers) high which makes it about three times higher than Mt.
