^{*}Although MATH 114 does not satisfy the Statistics requirement for WVU's College of Business and Economics, it will help students prepare for the more advanced STAT 211/ECON 225 requirement.

***Students are required to complete between 27-30 hours within the Business majors. Students will work with their advisor to distribute **Free Electives to meet the 120 credit hour graduation requirement or disregard this requirement to do so.

Students will be advised by West Virginia University's Center for Learning Advising and Student Success until completion of all required courses listed in Year Three, 1st Semester.

Students completing this proposed pathway may choose to major within one of the following College of Business and Economics fields:

Accounting; Management; Economics; Finance; General Business; Hospitality & Tourism Management; Management Information Systems; or Marketing

To be admitted to the College of Business and Economics, students must have an overall GPA of 2.5. To be directly admitted to their desired major, students must also complete the following College of Business and Economics prerequisite courses with a minimum grade of C or better:

CS 101 (WVU); ECON 205 & 206; MATH 105 & MATH 150 (WVU); ENG 101 & 102; ACCT 201 & 202; and STAT 211/ECON 225 (WVU)

Certain degree pathways have additional requirements for admittance: Accounting requires:

B or higher in both ACCT 201 & 202

Economics requires:

- One B or higher and one C or higher in ECON 205 & 206
- B or higher in MATH 150

^{**}SOCA 101 and PSYC 101 are required by all Business & Economics majors, except for Economics. Students pursuing a degree in Economics may disregard this required course and align their total closer to 120 total hours.

Finance requires:

- B or higher in both ECON 205 & 206
- B or higher MATH 150

Management Information System requires:

• B or higher in MATH 150

Students should select at least one CAHS Elective listed on the WV HEPC Core Coursework Transfer Agreement to successfully complete WVU's GEF 2B requirement.

Students are required to complete 3 credit hours (one course) from each of the GEF Areas 4 through 7 before successful graduation from West Virginia University. Students following the plan of study above will complete GEF Areas 4, 5, and 6 prior to graduation from BRCTC. GEF 7 will need to be completed at WVU, in the final 2 years of study.

The recommended sequence of courses for the third and fourth years of study may include required major courses in the junior year for some majors and only BCOR courses for other majors. Please refer to the College of Business and Economics website (be.wvu.edu) for recommended sequences of courses for each undergraduate major.
