Although Blue Ridge CTC's ENGL 102 is not equivalent to WVU's ENGL 102, the College of Agriculture and Natural Resources will permit students to apply these open credits as the GEF 1 requirement per the WV HEPC Core Coursework Transfer Agreement.

Students should select at least one CAHS Elective listed on the WV HEPC Core Coursework Transfer Agreement to successfully complete WVU's GEF 2B requirement.

For this agreement, the following course substitutions are being allowed:

- ECON 201 – ARE 150
- ACCT 201 – ARE 110
- BUSA 310 – ARE 482
- BUSA 330 – ARE 431
- BUSA 320 – ARE 204

ACCT 202 (WVU's ACCT 202) and BUSN 200 (WVU's BUSA 380) have been approved to be utilized as a Restricted Elective.

ARE 491's summer internship is one of three options available to complete the Agribusiness Management Capstone requirement. Although it is the most commonly pursued option, students may forgo this summer session and complete the requirement via study abroad or thesis composition. Students are encouraged to work with their advisor to select the option that best suits their academic needs and interests.

Students are required to complete 3 credit hours (one course) from each of the GEF Areas 4 through 7 before successful graduation from West Virginia University. Students following the plan of study above will complete GEF Areas 4, 5, and 6 prior to graduation from BRCTC. GEF 7 will need to be completed at WVU, in the final 2 years of study.
